

Project Updates

Bull River Riparian Re-vegetation

 Final 319 report was accepted and final payment was received. DEQ 319 Contract for Dry Creek / Bull River Sediment Reduction and Revegetation Project has been closed out.

Vermilion River Restoration

• 319 Application for funding toward the next project on the Vermilion River, the Sims Meander Stream and Floodplain Restoration Project, was prepared and submitted on September 10. The review meeting for this application will be October 1 in Helena.

Watershed Restoration Plan

 Work continues on the update to the Lower Clark Fork Tributary Watershed Restoration Plan. Sarah nearly has a draft of a Prospect Creek subsection which will be sent out for review soon, along with sections on Marten Creek and Swamp Creek. She plans to work on the Rock Creek subsection next.

Watershed Symposium – October 10-12 in Whitefish, MT

- The Montana Watershed Coordination Council puts on a Watershed Symposium in the state every two years. This year it will be in Whitefish. This is a great opportunity to learn from other groups in the state, connect with funders, and hear about other approaches to restoration and watershed outreach. The theme for this year's Symposium is storytelling. I'll be giving a few presentations: one joint presentation on watershed restoration planning with Sam Tappenbeck and Sarah Bowman; and one about the development of restoration films and their distribution.
