#### FWP Update

- General rifle season opens Saturday, October 24. The hunter check station on the west side of Thompson Falls will be a CWD check station this fall and will be open from 11 am-dusk on the weekends and as well as on Mondays. Hunter can drop off their samples or have them collected by staff at the check station. For question call (406) 752-5501 or visit fwp.mt.gov/cwd.
- MFWP collected and released about 290 Westslope Cutthroat Trout into several miles of excellent tributary habitat above a waterfall in the Thompson River drainage in late September. Donor streams were first tested for fish pathogens, aquatic invasive species and all translocated fish were genetically tested prior to release. USFS staff assisted with packing the fish into their new home. This effort is part of a larger 5-year project to conserve local genetic stocks as many are in danger of being lost to hybridization or being replaced/displaced by non-native trout species.

#### **NRCS** Update

- Please welcome the new Sanders County District Conservationist, Dillon Martini. Dillon grew up
  in bolder went to UM, worked for FS for a while and then moved to NRCS in Wyoming then
  moved back to MT.
- The Plains Service Center is still in "Phase III" which means visitors are allowed with prescheduled appointments and social distancing and masks are required.
- The application deadline for EQIP is November 17<sup>th</sup>, 2020 for our 2021 program year. We are currently working on multiple applications for white pine restoration in the Green Mtn CD service area through our Targeted Implementation Plan (TIP).
- Troy and Brita are also working on a TIP on Bull River.

## **SW-08-20 Yellowstone Pipeline**

#### SW-28-20 Russell

- This project is a platform and dock installation at 37 Trestle Lane in Trout Creek. The bank is stable with good vegetation and the height of the bank is approximately 2 ft. Maximum of 10 linear feet of bank will be disturbed. Very little vegetation will be disturbed. The platform will be 4' x 4' steel frame anchored to the bank with helical screws. Because of the shallow water the dock will go into the water 60 ft.

#### SW-29-20 Rahn

- This project is a ATV path located at Old Barn Rd. lot 4B in Thompson falls. The proposal is that the path is 50inchs wide on a grade of approx. 14% that makes two runs across the slope and encompasses one cribbed switchback structure. The length of the trail would be 384 ft. disturbed area is 391 square yards.

  dock attached to the platform.

## SW-31C-20 Graves Creek (Discussion Only)

- One of the Supervisors and FWP spotted a possible violation on Graves Creek. This site has had a pond in the past and the previous owners (Fairbanks) received were told to stop diverting streamflow to the pond. It looks like new owners have again slightly altered the bed and bank and changed the channel to put water in a pond.
- The actual violation is on property owned by a trust with a Maryland address to cadastral.
- The pond is not visible from the road.
- This is a bull trout stream and there are concerns of the potential for juveniles to get entrained in the pond
- A site visit was schedule for Friday October 30th at 1:00 pm.
- Leona will call or send a letter to the landowners advising them of the site visit.




## Report to the Green Mountain Conservation District October 21, 2020

### **Project Updates**

## **Bull River Revegetation**

- This fall, I'll be completing some mortality replacement plantings with some help from partners and volunteers on properties throughout the Bull River.
- In the coming year, I plan to development some management / long-term strategies for all of our revegetation properties. I will also be planning for additional revegetation efforts – expanding current efforts and hopefully capitalizing on target outreach over the winter and spring through the private land stewardship program (below).
- Developing funding proposals this fall for planting along the East Fork Bull River on private and public land, removing fencing exclosures on Avista's wood duck property, and maintenance/planning work for all revegetation properties.

# Empowering watershed stewardship and restoration on private lands (223 grant):

- Received an extension for this grant through 2021.
- Plan to work with Troy Hidy on a possible Targeted Implementation Plan for riparian revegetation in 2021.

- Will work over the winter and spring (after fall busy season wrapping up field work before the ground freezes) on finalizing a draft website and drafting all content for mailing.
- Pollinator grant was approved for demonstration plots that we plan to build in 2021. Sims Meander Project: This month we are diving into final funding proposals necessary to set this project up for implementation in 2021, which includes a 2021 CFSA Sims Meander request that I would like GMCD to sponsor. I will send this out for review as soon as I have it, and it is due on November 2.
