#### 310 Activities

#### SW-36-20 Meadows

- Visit along Little Beaver Cr. at Mr. Meadows went well, Jason reviewed these notes, which are
  more a narrative than signed report form as we were all walking and talking and Mr. Meadows
  will resubmit an app, but at least it's a record of the visit and what was discussed.
- Sean, Jason and Terry met Mr. Meadows and a new, upstream neighbor, Matt @ 1:30. Talked and walked along Mr. Meadow's area of Little Beaver Cr. and got a better idea of the work originally proposed in the earlier incomplete and denied application. In seeing first-hand, the limited scope of the proposed removal of dead and flow blocking alder, the stable condition of the banks and low energy of the stream, and hearing Mr. Meadows commitment to stewardship, GMCD and MFWP concerns were much reduced.
- We advised Mr. Meadows to resubmit application with pictures of a typical problem area and an estimate of roughly how much dead alder would be removed from the limited areas highlighted in original application. This estimate could be in terms of how the dead alder removed would compare to multiples of a typical alder "clump" (i.e., four 4" to 6" diam alders in a typical clump). We observed the old bridge spanning timbers in creek deflecting flow and were OK with their removal. Advised Mr. Meadows to mention revegetation efforts including sticking willow cuttings in disturbed areas or naturally unstable areas in the new submittal (willow cuttings from upstream neighbor who offered to help plant in the fall).
- Other aspects including beavers (largely trapped out) and other revegetation or fencing ideas and neighboring landowners' involvement were discussed and we advised Mr. Meadows and his neighbor to contact Brita Olson/ LCFWG. Channel dynamics, overall stream potential, previous studies (Smith '95, recent reach assessment Watershed Consulting 2010, 04 &15 Avista fish sampling) and the potential for additional future work including instream staked wood structures and rock placement were also discussed. Mr. Meadows agreed that the best course would be to resubmit updated original dead Alder and old bridge spanner removal application and assess possibility of future work and a different application.

#### SW-06-21 Tiesvold

#### SW-17-21 Johnson

- Request a dock installation at 39 Boat Way W. 4" wide stairs from top of bank, horizonal down the slope ending at a 4'x4' landing. A 4' by 12' long ramp to edge of water and a 8' by 20' dock
- A motion to accept this as a completed application was made by Mindy, 2<sup>nd</sup> by Terry, motion carried.
- Landowner will plant vegetation
- Site visit is scheduled for 10:00 am Jason, Bill, April 26th

## SW-18-21 Lapeirre Re-submit

Green Mountain Conservation District Meeting NRCS Report April 16, 2021

- Someone has been offered the soil conservationist position in Plains and has tentatively accepted the offer.
- New changes in our covid restrictions, visitors are allowed in the office with an appointment.
- Eqip applications are being pre-approved. It looks like we will get 5 white pine restoration applications funded, 1 high tunnel application, and 1 cover crop application
- We are also working on developing a new TIP for stream restoration work in the Green Mtn CD service area in conjunction with the Lower Clark Fork Watershed Group. I will be presenting the TIP to the state committee the week of 4/19 in a 5 minute presentation.
- We are also working on 2021 CSP applications.
  - There has been updated guidance that there are no longer limits on how many renewals a CSP contract holder may receive. As a result, all current 2017 CSP General and CSP Renewal contracts are eligible to apply for renewals. We are expecting 6 people to be eligible this year. I think we may struggle to find new enhancements for producers, but we will work through that on an individual basis.
- We are receiving more calls for Conservation Technical Assistance (CTA), mostly in regards to seeding recommendations, help managing forests, cleaning up from the wind event, fireproofing land, etc.



# **Project Updates**

# Empowering watershed stewardship and restoration on private lands (223 grant) / Bull River Revegetation

- Have made 2 site visits with new Bull River landowners, a few more in that drainage interested, and my first few contacts from Elk Creek.
- Letters the rest of the major tributaries will be going out by end of this month.
- Drafted a press release / website version to post and sent out for review as well.

# Pollinator Program

 Held first work day with Leona and Elena, setting up plots at our three sites. We'll have our second work day on May 10 and then plant at the end of May or early June.

# Sims Meander Project:

- Will have draft letter of agreement between Avista and GMCD for this project soon (ask Sean about that if you have questions).
- Anticipate issuing RFP at the end of this week it is currently out for review.
- The USFS continues trying to work through the NEPA process. With a few new processes and people, there have been some delays, but we expected to have a decision in time for this summer's implementation at this point. In the event that we don't, the project will be delayed by 1 year.
